The client wants the planning and implementation of a photovoltaic system with a

This system is to be planned and implemented by the company Innotrading – Alexander C. Barth .

Agreement:

1. The client commissions the planner to plan a photovoltaic system based on the specifications of a meaningful specification. The bill of quantities must contain: execution location, individual designation of all areas/roofs to be covered, if desired, information on the material to be used and special features according to the client's specifications.
2. The client commissions the planner with the planning of an area/roof renovation/restoration according to customer specifications using a meaningful list of services. The bill of quantities must contain: execution location, individual designation of all areas/roofs to be repaired, work to be carried out, if desired information on the material to be used and special features according to the client's specifications.
3. After signing the planning order, the planner undertakes to collect data at the site as quickly as possible.

Deadline(s):

All areas/roofs specified by the client in the specifications are recorded and processed in the planning. For better orientation, the customer must submit an aerial photo with marking and numbering of the areas/roofs to be occupied/processed.

4. After the data has been recorded at the site, the planner undertakes to deliver a detailed concept within a previously agreed period of time.
5. The client undertakes to have all areas/roofs on which work is to be carried out checked and to submit a legally usable statics. On request and with a separate order, a structural engineer can also be provided for execution by the planner. The client bears the costs for this alone. If the client does not deliver/provide any statics and/or commissions one, we work according to customer specifications and immediately require a weighting of the areas per m² that is still to be assigned (e.g. statement: 20kg/m² can also be recorded per m² of area). It is noted on the binding order whether statics were available, delivered, created and/or a load/weighting was specified. No guarantee can be assumed for information on statics and/or information on weighting provided by the client.
6. The client undertakes to commission the implementation of the photovoltaic system within 4 weeks of the concept being presented by the planner. Otherwise, the planning costs of 1% of the planned net order amount(s) will be charged.
7. If the project cannot be implemented within the planned time due to unforeseen delays, the planning costs will be offset against the implementation costs.
8. The planning belongs to the planner until the final execution/implementation of the project. All plans/concepts created by the planner may not be made available to other market participants for inspection and/or. It is also prohibited to contact and/or commission the listed product providers directly or via third parties. Otherwise the planner will invoice the client for 15% of the project/order sum(s). If the costs/invoice for planning the project are paid by the customer, they can be used freely.
